Subject: Release of central assistance for LH&DC Scheme component "Peste des Petits-control programme" (PPR-CP) during the year 2017-18 to the State Government of Chhattisgarh – regarding.

Sir,

I am directed to refer to the subject cited above and to convey the sanction of the President of India for the payment of Grants-in-Aid amounting to Rs. 7.00 Lakh (Rupees Seven Lakhs only) to the state Government of Chhattisgarh towards expenditure on the "Peste des Petits-control programme" (PPR-CP), a component of 'Livestock Health and Disease Control' as first instalment of central assistance for the current Financial Year (2017-18) with the condition that 40% matching share will be provided by the State Government.

2. The Grants-in-Aid of Rs. 7.00 Lakh (Rupees Seven Lakhs only) have been released in accordance with the approved pattern of financial assistance under the Scheme. The release to the Chhattisgarh State Government is subject to the condition that the next instalment for release will be considered only after obtaining the information relating to fund-utilization and submission of Utilization Certificate by the Chhattisgarh State Government.
