ORDER

The President of India is pleased to impose a uniform ban on fishing by all fishing vessels **in the Indian Exclusive Economic Zone (EEZ) beyond territorial waters** on the East Coast including Andaman, & Nicobar Islands and West Coast including Lakshadweep Islands as per period mentioned below for conservation and effective management of fishery resources and also for sea safety reasons:

East Coast-from 15th April to 14th June 2019 (both days inclusive) (61 days)

West Coast-from 1st June to 31st July 2019 (both days inclusive) (61 days)

The traditional non-motorized units shall be exempted from this uniform fishing ban imposed in the Indian EEZ beyond territorial waters.

This issues with the approval of the Competent Authority.
